- 5) name of precursor in accordance with the regulation on the list of precursors, number from the International Register of Chemicals (CAS number) and HS number;
- 6) anhydrous base content in percentages (%);
- 7) quantity of precursors on 1 January ____, year for which the report is submitted;
- 8) total quantity of manufactured precursors (kg, l);
- 9) quantity that is used or processed (kg, l);
- 10) quantity of stocks on 31 December_____, year for which the report is submitted;
- 11) assessment of needs for the coming year;
- 12) other data relevant for the annual report on manufacture of precursors;
- 13) place, date, stamp (L.S) and signature of authorized person.

Article 3

Annual report on trade of precursors shall contain:

- 1) name and address of legal entity (phone, fax,e-mail);
- 2) name of responsible person;
- 3) trade authorization date and number:
- 4) trade name of preparation;
- 5) name of precursor in accordance with the regulation on the list of precursors, number from the International Register of Chemicals (CAS number) and HS number:
- 6) anhydrous base content in percentages (%);
- 7) quantity of precursors on 1 January , year for which the report is submitted;

- 8) total quantity of imported precursors (kg, l);
- 9) quantity of imported precursors given individually by country (kg, l);
- 10) total quantity of exported precursors (kg, l);
- 11) quantity of exported precursors given individually by country (kg, l);
- 12) total quantity delivered to legal entities in Montenegro;
- 13) quantity of stocks on 31 December_____, year for which the report is submitted;
- 14) assessment of needs for the coming year;
- 15) other data relevant for the annual report on trade of precursors;
- 16) place, date, stamp (L.S) and signature of authorized person.

Article 4

The reports on annual manufacture and trade of precursors shall be submitted in forms which make an integral part of this Rulebook (Annexes no. 1 and 2).

Article 5

This Rulebook shall enter into force on the eighth day of its publication in the Official Gazette of Montenegro.
