

Pursuant to Article 9 paragraph 2 of the Law on control of manufacture and trade of substances that can be used in the manufacture of narcotic drugs and psychotropic substances (Official Gazette of Montenegro 83/09), the Ministry of Health hereby issues the

Rulebook on the content of request for obtaining authorization for trade of precursors and the content of trade authorization

The Rulebook was published in the Official Gazette of Montenegro 4/2015 of 28 January 2015, and entered into force on 5 February 2015

Article 1

This Rulebook shall lay down the content of request for obtaining authorization for trade of precursors and the content of trade authorization.

Article 2

Request for obtaining precursors trade authorization shall contain:

- 1) name and address of legal entity (phone, fax, E-mail);
- 2) name of responsible person;
- 3) address of place of storage;
- 4) data on appropriate safety measures against unauthorized movement of precursors from the place of storage;
- 5) name of precursor in accordance with the regulation on the list of precursors, number from the International Register of Chemicals (CAS number) and HS number;
- 6) description of planned activity (import, export, transit, transport, storage, delivery, sale, purchase, mediation in purchase or sale of precursors);
- 7) other data relevant for obtaining authorization for trade of precursors;
- 8) place, date, stamp (L.S) and signature of authorized person.

Article 3

Trade authorization shall contain:

- 1) authorization number;
- 2) name and address of legal entity performing trade of precursors (phone, fax, e-mail);
- 3) name of responsible person in legal entity;
- 4) period for which authorization is issued;
- 5) name of precursor in accordance with the regulation on the list of precursors, number from the International Register of Chemicals (CAS number) and HS number;
- 6) activity of legal entity;
- 7) address of place of storage;
- 8) other data relevant for trade of precursors;
- 9) place, date, stamp (L.S) and signature of head of authority.

Article 4

The content of authorization referred to in Article 3 herein is given in forms no. 1 and 2, which make an integral part of this Rulebook.

Article 5

This Rulebook shall enter into force on the eighth day following that of its publication in the Official Gazette of Montenegro.
