

INSTRUCTION FOR APPLICANTS FOR OBTAINING/AMENDING/EXTENSION/CESSATION OF VALIDITY OF WHOLESALE AUTHORISATION FOR VETERINARY NARCOTIC DRUGS

I In accordance with the Law on Medicines ("Official Gazette of Montenegro" No 80/20) and Law about preventing drugs abuse (Official Gazette of Montenegro No 28/11 and No 35/13), the applicant for wholesale authorisation for veterinary narcotic drugs shall submit to the Institute the following documentation:

- 1) Completed <u>Application form for obtaining/amending/extension/cessation of validity of wholesale authorisation for veterinary narcotic drugs</u>, available on the portal of the Institute (<u>www.cinmed.me</u>) in the section <u>Inspectorate</u> > <u>Wholesale/Good Distribution practice</u> in the section <u>Instructions and forms</u>;
- 2) Evidence that the responsible person meets the requirements prescribed by law and secondary legislation adopted for its implementation evidence on completed education, evidence on work experience (copy of employment record book and CV) and completed training, marriage certificate, if applicable;
- 3) Full-time employment contract concluded with the responsible person, statement of continuous availability (24 hours) of the responsible person with contact details (mobile phone, e-mail), as well as Confirmation from Revenue Administration on work insurance; temporary work permit for the responsible person (applicable only for foreigners);
- 4) Evidence of disposal of means of transportation of medicines (e.g. evidence of ownership of the vehicle, use of vehicles, entrusting transportation activities);
- 5) Evidence of ownership, lease, outsource of storage activities or some other manner of having business premises at disposal;
- 6) Study on the fulfillment of minimum technical and construction conditions in the area for performing activities with a sketch of the space and the legend of the premises with marked measures;
 - 7) Evidence of having a backup power supply (aggregate, UPS (uninterruptible power supply));
 - 8) Sanitary approval:
 - 9) List of the equipment and technical data on it:
 - 10) List of employees (name and surname, position, level of education);
 - 11) Quality assurance policy or other equivalent document;
 - 12) Procedure for emergency recall of medicines from the market;
 - 13) Evidence of the existence of the computerized or other record keeping system;
- 14) Evidence of the existence of a specially secured space, lockable, at the entrance of which there is a clearly displayed notice that unauthorized persons are prohibited from accessing, for storing and holding active substances belonging to narcotic drugs or psychotropic substances, as well as finished medicines containing these substances defined by the Rulebook on determining the list of drugs, psychotropic substances and herbs that can be used for drug manufacture ("Official Gazette of Montenegro" No 041/18 from 28.06.2018, 057/18 from 10.08.2018). This does not apply to preparations containing drugs defined in Part II of the List of Drugs, nor to drugs containing psychotropic substances defined in Group 4 of the List of psychotropic substances and herbs, which are part of the Annex to the Rulebook on determining the list of drugs, psychotropic substances and herbs that can be used for drug manufacture, and **they are not required** to be stored in a specially secured space.
 - 15) Other documentation proving the fulfillment of the conditions prescribed by the Law and secondary legislation adopted for its implementation, if necessary.

Payment of prescribed fee is a condition for processing the application.

Wholesale authorisation shall be issued for an indefinite period of time, except for medicines containing narcotic drugs.

The Institute shall obtain the following confirmations from the competent authority, ex officio.

For the purpose of obtaining of Confirmation from competent authority that the legal person and the founder have not been punished in criminal proceedings for the offence of drug abuse and money laundering (Article 26 of the Law about preventing drugs abuse), the applicant shall submit:

- extract from Central registry of commercial entities for the legal person;
- copy of ID of the responsible person in the legal person.

For the purpose of obtaining of Confirmation from competent authority that the responsible person has not been punished in criminal proceedings for the offence of drug abuse and money laundering (Article 26 of the Law about preventing drugs abuse), the applicant shall submit:

- copy of ID of the responsible person for wholesale of medicines containing narcotic drugs.

II Applicant for amending the wholesale authorisation for veterinary narcotic drugs shall submit the following documentation:

- 1) Completed <u>Application form for obtaining/amending/extension/cessation of validity of wholesale authorisation for veterinary narcotic drugs</u>, available on the portal of the Institute (<u>www.cinmed.me</u>) in the section *Inspectorate* > *Wholesale/Good Distribution practice* in the section *Instructions and forms*;
- 2) Appropriate evidence, i.e. documentation from point I of this Instruction in relation to the amendment.

Upon receipt, the applicant shall be issued an invoice in accordance with the applicable decision determining fees for Institute's business operations in accordance with the Law, based on which payment shall be made with reference to the number of invoice/file. Payment of prescribed fee is a condition for processing the application.

III Applicant for the extension of the wholesale authorisation for veterinary narcotic drugs shall submit the following documentation:

- 1) Completed <u>Application form for obtaining/amending/extension/cessation of validity of wholesale authorisation for veterinary narcotic drugs</u>, available on the portal of the Institute (<u>www.cinmed.me</u>) in the section <u>Inspectorate</u> > <u>Wholesale/Good Distribution practice</u> in the section <u>Instructions and forms</u>
 - 2) Documentation referred to in points 2–16 of this Instruction.

Upon receipt, the applicant shall be issued an invoice in accordance with the applicable decision determining fees for Institute's business operations in accordance with the Law, based on which payment shall be made with reference to the number of invoice/file. Payment of prescribed fee is a condition for processing the application.

IV Applicant for cessation of validity of the wholesale authorisation for veterinary narcotic drugs shall submit the following documentation:

- 1) Completed <u>Application form for obtaining/amending/extension/cessation of validity of wholesale authorisation for veterinary narcotic drugs</u>, available on the portal of the Institute (<u>www.cinmed.me</u>) in the section <u>Inspectorate</u> > <u>Wholesale/Good Distribution practice</u> in the section <u>Instructions and forms</u>
 - 2) justification for the cessation of performing wholesale of veterinary narcotic drugs.

Upon receipt, the applicant shall be issued an invoice in accordance with the applicable decision determining fees for Institute's business operations in accordance with the Law, based on which payment shall be made with reference to the number of invoice/file. Payment of prescribed fee is a condition for processing the application.
